#### SFL Occupational Health and Safety Conference September 13 – 15, 2023

The SFL Occupational Health and Safety Conference is held annually for unionized workers in Saskatchewan to learn about the latest issues surrounding occupational health and safety.

The conference is open to all SFL affiliates and non-affiliates. Non-unionized workers are welcome to attend as well.

This year, our conference will be held September 13 - 15 at the Delta Hotels by Marriott located at  $405 - 20^{\text{th}}$  Street East in downtown Saskatoon. Hotel and parking information can be accessed at <u>Delta Overview</u>.

## **Course Descriptions**

#### SFL Occupational Health and Safety Conference September 13 – 15, 2023

#### 1. Prevention of Violence in the Workplace

Workplace violence can take the form of physical aggression such as hitting, biting or kicking. Violence in the workplace also includes verbal threats, swearing, name calling and bullying. Violence is not part of your job and the repercussions for workers can be devastating, affecting their physical and mental health and job satisfaction. For employers, it means reduced productivity and increased losses. This course is intended to assist joint OH&S Committees to identify the potential hazards in the workplace, conduct a risk assessment and recommend corrective action as they pertain to violence. Participants will have the opportunity to develop a plan for violence prevention.

#### 2. Occupational Health and Safety for Women

Healthy and safe workplaces are a basic right. This workshop will provide women activists with tools, materials and processes to address this key area of work life. You will develop an understanding of how workplace stress and other psychosocial hazards can affect us and how to deal with them. The workshop will help identify stressors that affect women such as job demands, job control, lack of support and violence/bullying, resulting in a lack of work life balance. We will discuss health and safety issues important to women and work on solutions and prevention strategies to reduce stress and eliminate hazards. Gender diverse folks are welcome to attend this course.

#### 3. History of Occupational Health and Safety

We have celebrated the 50<sup>th</sup> Anniversary of Occupational Health and Safety Legislation in Saskatchewan, the first of its kind! We will further explore how OH&S came to be in Saskatchewan and the ground-breaking legislation that forever changed workplaces for the better, making them safer, and giving workers the rights they need to be safe and healthy. Now let's take a deeper look into our history, how we got here, where we go from here and what we can do to strengthen and advance OH&S in our workplaces.

Whether you are a union leader, shop floor activist or a history buff, this course is for you.

#### 4. Occupational Health and Safety for Healthcare Workers

Healthcare workers are truly the experts of their work. Workers need to be involved in order to see improvements and ensure our workplaces become safer for all. This course will provide the tools you need to identify hazards, assess risks and become active in your workplaces when it comes to safety specific to healthcare, including your physical and mental health and safety. You will better understand how your work impacts your day-to-day activities.

This course is for all who work in healthcare, regardless of where you work or what you do.

#### 5. Occupational Health and Safety Act and Regulations

The purpose of this workshop is to provide activists with a working knowledge of how the OH&S Act and Regulations apply. The workshop will also address how committees are intended to work, their responsibilities and the individual's role as a union member. This workshop will show you how to use this legislation as a tool to advance OH&S in your workplace. You will be provided with information relevant to the updates and changes to the OH&S Regulations.

#### 6. Building Psychologically Healthy Workplaces

Mental health in the workplace is an issue impacting all workplaces and can no longer be ignored. Keeping the workplace healthy and productive is simply smart business and good for the bottom line. The vision for a psychologically healthy and safe workplace is one that actively works to prevent harm to workers' psychological health, including negligent, reckless or intentional ways, and promotes psychological wellbeing. Participants will gain an understanding of the new CSA standard, review the current workplace psychological landscape and learn strategies for implementing an effective psychological healthy and safe workplace program.

#### 7. Effective Occupational Health and Safety Committees

In this workshop you will learn how to make your OH&S committees more effective. We have been hearing about the challenges and cutbacks affecting OH&S committees and recognize that safety starts at this level. This course is designed for those workers who have experience working on OH&S committees and are looking to maximize the powers of their committees.

#### 8. Domestic Violence in the Workplace: Starting the Conversation

This course is designed to train union representatives in our workplaces to be able to respond to members who may be experiencing domestic violence. This may include stewards, health and safety representatives, staff or other workplace representatives. You will gain a deeper understanding of the dynamics of domestic violence at work and the roles of the union and employer in addressing it. You will learn ways to support members who may be experiencing domestic violence, including how to recognize and respond to the warning signs and risk factors. We will start the conversation to bring awareness about domestic violence at work among your memberships and learn about pathways to community-based experts. We will discuss language for collective bargaining and legislative initiatives.

This course is open to all genders and male participation is encouraged.
