In recognizing a need to build capacity and provide opportunities for these workers, the SFL encourages affiliates to send young workers to the SFL Convention. As such, the Constitution provides for additional delegate credentials for unions that send young workers as part of their delegation to the SFL Convention.

Please contact the senior representatives of your union should you have a member who is interested in attending the SFL Convention as a young worker delegate. We ask all affiliates to give consideration to ensuring representation from equity-seeking groups (women, Indigenous, visible minorities, persons with disabilities and 2SLGBTQ+).

YOUNG WORKER QUALIFICATIONS

Delegates must be no more than 29 years of age on the opening day of convention on October 23, 2024, as per the SFL Constitution, Article 4. All delegates must be a member of an affiliated organization in good standing with the Federation (see 'Affiliate and Delegate Qualifications' in the 2024 Convention Call).

YOUNG WORKER REPRESENTATION

Representation for young workers from affiliated unions at convention is in accordance with the SFL Constitution:

Members	Young Worker Credential Entitlement
1000 or less	1 delegate
1001 - 5000	2 delegates
5001 - 8000	3 delegates
8001 or more	4 delegates

Membership is the average number of members on whom per capita has been paid for the 12 months preceding the SFL's year end.

Each Labour Council is entitled to 1 young worker delegate credential.

REGISTERING YOUNG WORKER DELEGATES

To ensure young worker credentials are above and beyond the standard affiliate representation calculation, young worker delegates and alternates must be registered using the Young Worker Credential Form.

Otherwise, the registration process, fees, payment, and deadlines are the same for all young worker delegates as indicated in the main Convention Call.
